Guardian's address and telephone number; 24 2. If the ward is no longer in the guardian's home, why the ward was moved and the name, relationship, 25 address, and telephone number of the person or persons with whom the child resides; 26 3. Any significant physical or mental health issues of the guardian or ward impacting the ability of the 27 28 guardian to continue in their capacity as guardian;

1	4. Any significant change, traumatic event, or major disruption impacting the ward or the guardian's
2	ability to continue in their capacity as guardian; and
3	5. The guardian's inability to continue their duties and obligations as the child's guardian.
4	IT IS FURTHER ORDERED, ADJUDGED, AND DECREED THAT nothing herein shall limit the
5	court from ordering a guardian to appear before the court and/or to file a status report as described in
6 7	Probate Code §1513.2(a) at any time.
