11 **STANDING ORDER OF THE COURT**  
12 **APPOINTING PUBLIC GUARDIAN AS**  
13 **PROBATE CONSERVATOR AND**  
14 **AUTHORIZATION OF INDIVIDUALS TO**  
15 **EXECUTE DOCUMENTS**

16 Based upon the Ex Parte Application of Judith A. Holiber, Deputy County Counsel, as attorney  
17 for the Office of the San Mateo County Public Guardian, and, for good cause appearing,

18 **IT IS HEREBY ORDERED:**

19 1. That the Public Guardian for the County of San Mateo is the agency designated to serve as  
20 Probate Conservator of the Person and Estate of those individuals who are unable to meet their basic  
21 needs for physical health, food, clothing, or shelter, and/or who are unable to manage his/her own  
22 financial resources or resist fraud or undue influence when no other person is appointed to serve in that  
23 capacity. The Public Guardian for the County of San Mateo is appointed as Conservator of the Person  
24 and Estate in LPS Conservatorship proceedings when the individual under the disability of the  
25 Conservatorship is suffering from a mental illness or mental disease.

26 2. That Charlene A. Silva is the duly appointed Public Guardian for the County of San Mateo. By  
27 way of this Order, the Court hereby authorizes the individuals named in this Order to execute any  
28 document required for the sale or transfer of real property and/or personal property, including all stock

1 and cash reserve transfers and redemption of bonds. The individuals who are authorized to execute these  
2 documents on behalf of and in the place of Charlene A. Silva are:



12 5. That this Order shall be a Standing Order of the Court and shall remain in full force and effect  
13 until it has been revoked by the Court.




