#### Programs Initiated by Presiding Judge George A. Miram

Judge Miram's two-year term as Presiding Judge for 2005-2006 has seen the development of a number of innovative programs to help the citizens of San Mateo County. Under Judge Miram's watch, the Court has expanded its community outreach efforts, continued to improve services to jurors, expanded community law night to the northern part of San Mateo County, created and implemented a new mental health court (Pathways), and began the first of its kind high tech complex civil litigation court in our San Mateo branch court.

The judiciary and court staff alike have appreciated Judge Miram's leadership, dedication and commitment to bringing these positive changes to our Court and community.



Recently, the judges elected Assistant Presiding Judge Robert D Foiles to be the next Presiding Judge for the 2007-2008 term. At that same meeting, the judges elected Judge Stephen M. Hall to be the Assistant Presiding Judge for the next two years.

The Presiding Judge acts as the Court's chief administrative judge and determines judicial assignments, manages the court calendar, assigns out cases, manages the budget, and oversees the Court's community outreach efforts.

Both Judge Foiles and Judge Hall bring a wealth of administrative experience to these positions. Judge Foiles has served as Assistant Presiding Judge for 2005-2006, Supervising Civil Judge in 2004-2006, Supervising Criminal Judge in 2003, Criminal Presiding Judge in 2000, and Family Law Judge 1998-1999.

Judge Hall has served as Supervising Judge of Commissioners and Pro-tems in 2004, Supervising Judge of Criminal in 2003, Supervising Judge of Family Law for 1998, 1999, 2000 and 2002, and Criminal Presiding Judge in 2001 and for the first six months of 2005.

#### **Other Judicial Updates**

The Court is pleased to announce with the early appointment of Judge Susan Irene Etezadi in the fall, that for the first time in many years, the Court's bench is fully staffed. Prior to being elected into her position in June, Judge Etezadi worked in the District Attorney's Office for over twenty years where she prosecuted a wide variety of cases ranging from homicides to insurance fraud. We welcome Judge Etezadi and look forward to her many years of service to the Court.



The Court is also very appreciative to the State Administrative Office of the Courts for assigning retired Judges Quentin Kopp, John Schwartz, and Thomas McGinn Smith to our Court on a regular basis. The assignment of these judges back to our Court is a major factor in keeping our court calendar current. Additionally, retired Judge Paula Schlichter and Commissioner Joseph Gruber have provided assistance with court calendars this past year. We appreciate the significant contributions that each of these judicial officers makes handling a wide variety of different assignments
