Presiding Judge for 2005-2006, Judge George A. Miram, has issued the Judicial Assignments Order for 2005 which is posted on the Court's website. In addition to these changes, Judges Forcum and Miram have ordered the following changes in calendars effective January 3, 2005, to remedy a current backlog of cases in Family Law:

- 1. The DVPA/OSC calendar previously heard by Judge Scott on Wednesday morning is transferred to Commissioner Greenberg to be heard Wednesday afternoons.
- 2. Judge Pfieffer will hear the Thursday Criminal Domestic Violence Calendar in South San Francisco. Judge Scott will hear the Wednesday Criminal Domestic Violence Calendar in Redwood City.
- 3. LPS trial settings currently heard by Judge Pfeiffer on Thursday mornings at 11:00 a.m. are to be heard on Wednesdays at 11:00 a.m.
- 4. No Probate matters or Probate Ex-Partes will be heard on Thursdays.
- 5. A new Trial Short Cause calendar will be established for Judge Scott on Thursday mornings in Redwood City.
- 6. Short Cause matters previously set for Judge Scott on Wednesday afternoons will be transferred to Thursday afternoons.
- 7. The Family Law Clerk's Office has been directed to contact Family Law attorneys on cases set for trial or short cause in front of Judge Scott to move cases set in June, July, and August and reset them on dates in January, February, March, April on the new Thursday morning Trial or Short Cause Calendar.

Our administrative goal is to try and balance Family Law calendars with consistent setting times for all three Family Law Departments.

DRUG COURT—REDWOOD CITY
