# BACKGROUND

California law<sup>1</sup> requires the Civil Grand Jury to "submit to the presiding judge of the superior court a final report of its findings and recommendations that pertain to county government matters during the fiscal or calendar year." Responses and any comments from the governing body, elected officer, or agency head to which such findings and recommendations are directed must be submitted to the presiding judge of the superior court within the period of time specified in that law.<sup>2</sup> Governing bodies of public agencies are required to respond no later than 90 days after the Grand Jury submits a final report, elected county officers and agency heads no later than 60 days. Grand Jury reports and the responses from prior years can be reviewed on the following website: http://www.sanmateocourt.org/court\_divisions/grand\_jury.

Each year, the Grand Jury reviews the responses and comments submitted with respect to recommendations issued by the prior year's Grand Jury in light of California Penal Code Section 933.05(b). Each responding agency head, county officer, or governing body *shall provide one of only four possible responses* – namely, that the recommendation:

- 1. Has been implemented, with a summary of the action taken;
- 2. Will be implemented, with a timetable for the implementation;
- 3. Requires further analysis, with an explanation and a timeframe for the response of up to six months from the release of the report;
- 4. Will not be implemented because it is not warranted or is not reasonable, with an explanation for that response.

# SUMMARY OF RESPONSES

The 2020-21 Grand Jury issued six investigative reports that included recommendations to county, local or district agencies. This year, the 2021-22 Grand Jury reviewed the formal responses to recommendations that the affected agencies submitted in response to the 2020-21 Grand Jury reports.

The tables that follow immediately below summarize the responses to each of the investigative reports issued by the 2020-21 Grand Jury across all agencies. <u>Appendix A</u> presents more detail about the individual agencies' responses to each of those reports, spelling out each report's recommendations and each agency's responses to those recommendations. One column indicates whether follow-up by a future grand jury is advisable. This information is designed to help the public evaluate whether and to what extent agencies have responded to recommendations of the Grand Jury.

### APPENDIX A: SUMMARY OF RESPONSES TO THE 2020-2021 SAN MATEO COUNTY CIVIL GRAND JURY FINAL REPORTS

"Building Greater Trust Between the Community & Law Enforcement via the Racial and Identity Profiling Act"

Report Issued July 27, 2021

#### RIPA Data Collection and Reporting – Milestones for January 1, 2022 compliance

- **R1.** Each LEA must have a fully developed implementation plan for complying with RIPA. The plan should include data collection and reporting, training methods, policies and procedures, roll-out plans, personnel allocation, systems testing and data auditing. The plan should be reviewed and approved by October 30, 2021.
- **R2.** Each LEA needs to acquire the necessary software and hardware required to comply with RIPA by October 30, 2021, in order to complete testing within 30 days and to go live by January 1, 2022.
- **R3.** Each LEA must test and confirm their readiness for RIPA data collection by November 30, 2021.
- **R4.** Each LEA should provide regular updates to their governing entities, on their progress *toward preparing* for the required RIPA data collection starting on October 15, 2021.

#### Using RIPA Data for Transparent Community Trust Building – don't wait for the annual report

- **R5.** Each LEA should, on a quarterly basis, starting in the second quarter of 2022, provide reports on RIPA data and how it is being used to address potential identity biases, including supervisory oversight (as defined by the RIPA Board). The report should be posted and easily viewable on the entity's website.
- **R6.** By February 1, 2022, each LEA should begin considering how to obtain and use insights gained from the RIPA data to improve the operation of its department by combating implicit bias in policing and pursuing greater community trust by implementing the RIPA Board's growing list of policing best practices.
- **R7.** By February 1, 2022, each LEA should consider community engagement and transparency, including the possible use of "academics, police commissions, civilian review bodies, or advisory boards" as a mechanism to build community trust and provide bias-free policing.
- **R8.** In the second quarter of 2022, each of the contracting entities should begin requesting RIPA stop data for its jurisdiction, separate from the rest of the Sheriff's stop data.

### "Sexual Assault Kit Testing Reports in San Mateo County: What are We Missing?" Report Issued August 3, 2021

- **R1.** Beginning in May 2022, the Sheriff's Office should adjust the timing of the release of the annual Sexual Assault Kit Testing Report from January to May of each year so that the report reflects complete data from the previous calendar year.
- **R2.** Beginning in May 2022, the Sheriff's Office should expand the content of the annual Sexual Assault Kit Testing Report to include:
  - the total number of sexual assaults in the County as reported to the FBI;
  - the number of sexual assaults in each city as reported to the FBI; and
  - the reasons sexual assault kits were not processed. The information should not include the victims' information or city of origin and only include the number of kits cancelled by category.
- **R3.** To increase public transparency, the Sheriff's Office should, commencing no later than May 2022, announce the availability of the annual Sexual Assault Kit Testing Report in a manner designed to maximize public awareness.

# "Building a Racially & Ethnically Diverse Teaching Workforce: A Challenge for Our Schools"

Report Issued August 6, 2021

- **R1.** By June 30, 2022, school districts should include a commitment to teacher diversity in their strategic plans, goals, and/or objectives, using the Strategic Plan developed by the San Mateo County Office of Education as an example. These aspirational documents should be *prominently and publicly displayed on their website*.
- **R2.** The San Mateo County Office of Education should regularly sponsor teacher diversity forums, and invite superintendents, district human resource managers, principals, and school board members to participate. The forums should address current challenges districts face with regard to recruiting teaching staff in general, and teachers of color, and share best practices and strategic solutions. This should begin in advance of next year's recruiting cycle, no later than April 30, 2022.
- **R3.** The San Mateo County Office of Education should expand its outreach to school districts and publicly share the demographic data of all learners and educators in the County when its planned report is completed, but no later than the end of the 2021-22 school year.

### "San Mateo County: California's Ground Zero for Sea Level Rise" Report Issued August 11, 2021

The Grand Jury recommends:

- **R1.** At a public meeting, each city and town council, or board of supervisors should take at least one concrete action toward establishing a continuing funding source for OneShoreline, identify that action in response to this report, and potentially adopt a resolution expressing support for a parcel tax or property tax by June 30, 2022.<sup>10</sup>
- R2. A coordinated lobbying strategy with participation by the County, by San Mateo County cities and towns, by OneShoreline, and by other interested Bay Area cities and counties for federal and state regulatory simplification by January 31, 2022.<sup>11</sup>
- **R3.** OneShoreline consider establishing and administering a low interest revolving loan fund to enable jurisdictions to prepare the initial engineering and planning necessary to obtain federal and state funding for SLR projects, establishing such program by December 31, 2021.
- **R4.** The County Board of Supervisors and each city and town council, should ensure that their general plans regarding SLR protection include transportation and utility infrastructure, schools, public safety facilities, and hazardous material sites by March 31, 2022.

### "Where's the Plan for the San Mateo County Emergency Alert System?" Report Issued August 11, 2021

- R1. By October 1, 2021, the Board of Supervisors should instruct the San Mateo County Manager's Office to complete the County's Emergency Alert System Plan and publish it to all affected Office of Emergency Services personnel and the State Emergency Alert System Committee. The plan should meet the minimum requirements as listed in the *State of California Alert and Warning Guidelines, March 2019*.
- R2. In addition to the minimum requirements, the San Mateo County Emergency Alert System Plan should include:
  - benchmarking with nearby county Office of Emergency Services / Bay Area Urban Area Security Initiative agencies to identify overall Emergency Alert System best practices for improvement and consistency throughout the Bay Area.
  - comparisons with other counties' Emergency Alert System websites to identify opportunities for consistency and continued improvement.
  - a section describing language translation protocols, including how translators will be used.
  - mandatory participation by Office of Emergency Services staff in annual Emergency Alert System Plan refresher training as recommended by the State Guidelines.
  - a section addressing an Office of Emergency Services succession plan to assure appropriately trained personnel are available to replace key personnel necessary for operation of the Emergency Alert System; and
  - a section addressing how the expected enrollment increases resulting from utilization of California Penal Code Section 8593.4(a) will be managed.
- R3. By October 1, 2021 (and annually thereafter) the newly completed Emergency Alert System Plan should be verified using the "State of California Alert and Warning Guidelines, March 2019 Appendix Minimum expectation checklist for jurisdictions and designated alerting authorities implementing an alert and warning program within the State of California" (See Appendix B).
- R4. By December 1, 2021 (and annually thereafter), the Office of Emergency Services should provide Emergency Alert System Plan training for County employees with responsibilities related to the Plan and offer the training to outside agencies that use the Emergency Alert System to send alerts.
- R5. By December 1, 2021, the County Manager's Office should prepare a plan outlining the Office of Emergency Services' strategy for implementing legislation (California Penal Code Section 8593.4(a)) that would increase resident Emergency Alert System enrollment.
- R6. By December 1, 2021, the Board of Supervisors should instruct the San Mateo County Manager's Office to compile a list of potential translation services who can provide expanded translation services for the Emergency Alert System.

#### **Diversity-Related Recommendations**

- **R1.** The Board of Supervisors should direct the County Manager's Office to create, and annually present, a report detailing the racial, ethnic, and gender diversity of management and leadership positions within the San Mateo County government workforce, change from prior years, and the effectiveness of specific programs to remediate any gaps, by January 31, 2022.
- **R2.** The Board of Supervisors should direct the County Manager's Office to require an annual report from each department of San Mateo County government (including performance measures, and accountability), detailing the racial, ethnic, and gender diversity of that department's workforce and the efficacy of its programs to remediate any gaps, by January 31, 2022.
- **R3.** The Board of Supervisors should direct the County Manager's Office to create, and annually present, a report recommending potential improvements to San Mateo County's current practice of reporting to the public on the status of racial, ethnic, and gender diversity in the San Mateo County government workforce, and associated performance goals, by January 31, 2022.

### **Racial Equity-Related Recommendations**

- **R4.** The Board of Supervisors should direct the County Manager's Office to develop a set of recommendations, such as a model racial equity action plan, to help departments accomplish organizational change promoting racial equity in their work, by January 31, 2022.
- **R5.** The Board of Supervisors should discuss, in an open public meeting, the advisability and practicality of the measures identified as best practices in the Discussion section of this report, by January 31, 2022.
