WHEREAS, Government Code section 25259.7 provides that "Any collection program that is operated by a court may apply to the presiding judge of the court for a discharge from accountability for any court-ordered debt or bail that it would otherwise be responsible for collecting, if the amount is too small to justify the cost of collection or the likelihood of collection does not warrant the expense involved; and

WHEREAS, the Court's Revenue Collections Unit (RCU) within the Finance Division, submitted an application pursuant to Government Code section 25259.8 recommending the Court discharge from accountability 522 cases with dismissed marijuana convictions and with debt totaling \$143,317.67 that are (1) cases having a balance of \$100 or less and/or (2) misdemeanor or and felony cases where at least 10 years have elapsed since the date of last payment or the date the account became delinquent (see Exhibit A); and

WHEREAS, pursuant to Government Code section 25259.8, the RCU provided a list with each case name, case number, amount to discharge, date of last payment, and reason for recommending discharge from accountability (see Exhibit B); and

WHEREAS, these cases have low levels of balances due and/or meet the criteria for infraction cases that are highly unlikely to pay or further pay such that they do not justify the further cost of collections;

NOW THEREFORE, FOR GOOD CAUSE SHOWN, IT IS HEREBY ORDERED THAT the RCU be discharged from referring the debt on the 522 cases identified in Exhibit B to the Court's collections agency. Pursuant to Government Code section 25259.9, this order does not, however, constitute a release of any person from liability for payment of any amount.

**APPLICATION FOR DISCHARGE FROM ACCOUNTABILITY
(Government Code Section 25259.7)**

The Court's Revenue Collections Unit (RCU) respectfully applies to the Presiding Judge of the Court for a discharge from accountability for the court-ordered debt on 522 cases listed in Exhibit B that it would otherwise refer to the Court's collections agency. The request is based on one or both of the following: 1) the balance of \$100 or less is too small to justify the cost of collections or 2) at least ten years have elapsed from the date of last payment or the date the account became delinquent.

Pursuant to Government Code Section 25259.9, upon discharge, the RCU will not refer the debt to its collections agency for collection of the debt. A discharge from accountability does not constitute a release of any person from liability for payment of any amount owed. The total amount requested to be discharged from accountability is \$142,317.67. The names of the persons liable, the amount owed, and the reason for recommending discharge are provided in Exhibit B.
