## HOW TO PAY CRIMINAL FINES

**Within 10 days of order:** Criminal Clerk's Office, 400 County Center, 4<sup>th</sup> Floor, Redwood City, CA , open 8am-4pm. The Clerk's Office accepts only payment in full, by cash, check, money order, or major credit card. Please have exact change for cash payment. You may also pay by credit card on our payment portal at [www.sanmateo.courts.ca.gov/portal](http://www.sanmateo.courts.ca.gov/portal).

**After 10 days:** Please contact Linebarger (Linebarger Goggan Blair & Sampson, LLP), the San Mateo Superior Court payment processor. You may pay in full or set up a payment plan.

- Credit/Debit Card

You can pay online using credit/debit card at: [www.lgbswebpayments.com](http://www.lgbswebpayments.com). You will need to enter your court case number in order to make payment.

- Check/Money Order
